The DEFENDER BR provides body/impact protection when handling granular brasives and, due to the 3-layer fabric and the sealed seams, additional protection against

**Assembly** – Standing collar

- 1-way zip with double cover and press studs

- 1 vertical inside breast pocket with zip (Napoleon pocket)

- Waist adjustment by fixable elastic band

- Sleeve and leg ends with velcro straps for width adjustment

- Inner safety cuffs in sleeve ends

- Knee-high inner safety cuffs in leg ends

Elastic band at cuff endsWelded seams on the inside

- Outer hanger

Fields of application Disposal / Sanitation / Cleaning

**Warning** Do not use dissolvents, fold only in dry condition.

Safety instructions Protection is only guaranteed if a suitable respirator is worn at the same time

as the overall. A suitable respirator is worn at the same time as the coverall.

Before an operation, it must be checked whether, in addition to the overall and respiratory protection suitable eye, hand and foot protection must be worn

in addition to the overall and respiratory protection.

In view of the various items of clothing that are usually worn under the coverall, it is recommended that the coverall, it is recommended to choose a larger size in case of doubt. The air cushion created by this provides additional protection.

Protective clothing must always be put on and properly fastened before entering hazardous areas and properly closed before entering hazardous areas.

Before each use/re-use, the protective clothing must be inspected to ensure that it is undamaged condition.

It is recommended to rinse the protective clothing with water immediately after contamination rinse with water immediately after contamination.

**Cleaning, care** Surface dirt can be removed with soap agents.

**Storage** Storage can be removed by wiping/brushing.
